International, National and Local Motorcycle Affairs

United Nations General Assembly: Passed a resolution titled: "Improving Global Road Safety." The Ambassador Samantha Power, U.S. Permanent Representative to the United Nations, agreed to co-sponsor the resolution that "calls for laws to fight texting and driving. The resolution also contains language calling for mandatory helmet laws, and harmonization of vehicle regulations in the name of "safety". *(Editor's Note: This resolution is non-binding. The United Nations can't control Iraq, Syria, Ukraine, Somolia etc. so who's going to enforce helmet laws?)*

National: **Over \$50,000.00 of funds dedicated to highway safety have been spent on motorcycle-only checkpoints. End motorcycle-only check points by visiting the American Motorcycle Association page @ <http://www.americanmotorcyclist.com/rights>.

****Grow America ACT, U.S. Department of Transportation:** Allows the National Highway Traffic Safety Administration to lobby states in support of mandatory helmet laws. See Section 4004. Amendment to Motorcyclist Safety Grant Criteria, Section 405(f), title 23, United States Code, paragraph 5. *(Editors Note: This language was struck from the legislation which then passed June 9th, 2014.)*

****FEDS to include motorcycles** in intelligent transportation systems: National Highway Traffic Safety Administration (NHTSA) intends to include motorcycles in the research they will be doing on vehicle-to-vehicle (V2V) communication technology. V2V communication works like this: if a vehicle is approaching another vehicle at a greater rate of speed and a collision is imminent, the vehicle will brake itself to slow down and avoid the collision. Or, if a distracted driver is bearing down into your vehicle's space, it will automatically employ evasive actions such as hard braking or swerving.

****MOTORCYCLE THEFTS** continue downward, except for Harley-Davidson which increased by 4%, as reported by the National Crime Information Center, an electronic clearinghouse of nationwide crime data aggregated by the FBI. Last year 45,367 motorcycles were stolen, the equivalent of one stolen every nine minutes, is down 1.5%, even as bike sales increased. Honda was the most stolen motorcycle, followed by Yamaha, Suzuki, Kawasaki and then Harley's. The thefts were highest in California, followed by Florida, Texas, North Carolina and Indiana. Thirty-seven percent of stolen motorcycles are recovered, compared to 50% of stolen cars.

****SAVE THE PATCH:** The Mongols Motorcycle Club has won the Mongols Motorcycle Club case again. In a ruling issued September 21st and filed September 24th, Federal District Judge Otis D. Wright has ruled that the United States cannot seize the name and patch of the club. Judge Wright ruled that his previously issued “preliminary order of forfeiture is rendered invalid.” The issue of whether the Department of Justice and the ATF could simply steal the name and the patch of the Mongols Motorcycle Club was settled definitively in July 2009. But then Christopher Brunwin and Steven Welk, two of the prosecutors in this case, as well as the Alcohol Tobacco Firearms Agents who had created the case, just simply refused to believe they had lost and the Mongols had won. The presiding judge then, the late Florence-Marie Cooper wrote an angry decision which stated unequivocally that the government could not seize the marks. Last week Judge Wright wrote, “United States District Court Judge Florence-Marie Cooper already ruled upon the issues relevant to this proceeding.”

In short, the prosecutors in this case have argued for two years that former Mongols president Ruben “Doc” Cavazos could forfeit the Mongols name and patch as part of his “punishment.” Two federal judges have now ruled the Mongols insignia is not Cavazos’ to give away.

Last week, Judge Wright wrote: “Even if the Court were to accept the Government’s evidence that Ruben Cavazos controlled the use of the mark during his tenure as National President, there is no support for the notion that a defendant’s control of property belonging to a RICO enterprise is sufficient to establish a forfeitable ownership interest in the property. In addition, there is no evidence that Ruben Cavazos owned a majority interest or any interest in the Mongol Nation that would equate to an ownership interest in the mark. There is no evidence that Shotgun Productions, LLC ever used the mark as a collective membership mark – to indicate membership in an organization substantially similar to that of the Mongol Nation. The purported assignment to Shotgun Productions, LLC is therefore without legal effect. Moreover, the Government’s evidence demonstrates that the Mongol Nation began using the collective mark in approximately 1969, and either Mongol Nation or (MNMC) continues to use the mark to identify their members. (Guevara Decl. ¶ 6.) The Mongol Nation and (MNMC) by virtue of having used the collective membership mark since 1969, having registered the mark in 2005, and having continued use of the mark to identify members of the club, have acquired and maintained exclusive ownership in the collective membership mark at issue.”

****Drivers Privacy Act, S. 1925:** Among its provision, this measure clarifies that the owner of a vehicle is also the owner of any information collected by an Event Data Recorder installed in the vehicle, and law enforcement must obtain a warrant or court order before taking the Event Data Recorder. S. 1925 is currently pending before the Senate Committee on Commerce, Science and Transportation for review. There is conversation that this mechanism will be installed on motorcycles. This bill was introduced in a previous session of Congress and was passed by the Senate on April 26, 2012 but was never passed by the House. Mark Begich voted for this bill and Lisa Murkowski voted against it (See Senate vote, April 26th, 2012 (112th Congress)).

LOCAL: The Alaska Department of Transportation and Public Facilities (ADOT&PF), in consultation with the Alaska Department of Fish and Game (ADFG), is conducting statewide vegetation management on state highways this summer with the primary goal of improving traveler safety. Left uncontrolled, roadside vegetation can obstruct motorists’ line of vision and limit their view of the road ahead, traffic control devices, approaching vehicles and wildlife. Abundant woody vegetation along roadsides provides winter browse and can encourage moose to spend time near roads. Moose collisions can result in serious injuries or death as well as significant damage to vehicles. The Department of Fish and Game supports effective vegetation management along roads and highways to reduce the risk of vehicle collisions with wildlife.

The two agencies collaborated to identify highway corridors that require special maintenance attention. The following tactics are being implemented to improve traveler safety on Alaska’s highways:

- Removing and disposing vegetation that attracts wildlife species to the roadside.
- Improving sight distance and visibility of signs and markers.
- Removing possible roadside hazards, such as trees.
- Decreasing shaded areas to increase the effectiveness of snow and ice maintenance efforts.
- ADOT&PF and ADFG recently formed the Wildlife and Highways Workgroup to promote traveler safety, efficient transportation, and economical ways to plan, design, and operate Alaska’s highways while reducing negative impacts to wildlife populations.

SAFETY RECALLS

HD Issues Recall on 2014 Sportster XL Motorcycle Chrome Hand Control Levers: Harley Davidson has issued a recall for certain Chrome Hand Control Lever Kits, part number 3670053, intended for use on 2014 Sportster XL motorcycles. The reason is that affected kits may have excess chrome plating on the brake lever which could prevent the front brake master cylinder piston from fully returning. This could cause front brake pressure to not be fully released and may cause the front wheel to lock up, which could lead to a crash. Harley Davidson is notifying owners of the affected levers and dealers will inspect and replace them as necessary with no charge to the owner. HD Issues Recall on 2014 Touring and CVO Touring motorcycles: Harley is recalling 66,421 Touring and CVO Touring motorcycles from the 2014 model year. It warns that the front wheels can lock up without warning. The recall applies to bikes with anti-lock brakes made between July 1, 2013, and May 7. The flaw has resulted in five crashes, with two minor injuries. The snafu occurs when a brake line in front is pinched between the fuel tank and the frame, causing the front brake fluid pressure to increase and increasing the risk that the front wheel could lock up while riding. Dealers will replace brake lines and install straps to keep them in place.

HD Issues Recall on 2014 Trikes: National Highway Traffic Safety Administration (NHTSA) issued a recall notice for certain 2014 HD trikes due to an "incorrectly machined" fork bracket stem that may contribute to "an excessive steering angle allowing the inner fairing to contact the rear brake fluid reservoir resulting in a loss of brake fluid." The issue may damage the steering damper and there are potentially 436 units affected by the recall. HD will replace the fork bracket stem free of charge. Harley's recall identification number is 0152 and owners may call 1-800-258-2464 for more information. Owners may also contact NHTSA at 1-888-327-4236 or go to www.safercar.gov. The NHTSA campaign number is 13V491000.

BMW of North America is recalling 950 2014 R1200RT motorcycles produced between November 27, 2013 and May 5, 2014 for a problem with the Dynamic Electronic Suspension Adjustment (ESA) rear shock absorber. The piston rod within the rear shock absorber can break without warning, causing loss of stability. More information and details of the recall can be found here:

BMW will notify owners, and dealers will replace the Dynamic ESA shock absorber, free of charge. The recall is expected to begin in July 2014. Owners may contact BMW Customer Relations at 1-800-525-7417. Note: Owners are advised not to ride their motorcycles until they have been remedied (<http://bmwcmag.com/2014/06/2014-bmw-r1200rt-recall-coming>).

YAMAHA: 2005 Yamaha FJR1300. SOME of the 04 and 05 models developed the infamous valve "ticking" problem at early mileage. Not a safety issue, but costly. The valve guides inside the cylinder head were improperly designed so that some didn't get enough oil supply. The valve stems wore out the inside of the guides and slopped around, banging off of the guide walls, sounding like ticking, eventually ruining the heads. Yamaha would replace the head on warranty if an owner bitched loud and long enough, but otherwise ignored it. Some guy back east I think started a consumer grass-roots movement over the internet to organize owners with problems. This collective gathered some clout and made Yamaha face up, but the corporation never officially acknowledged that it had a destructive design flaw. The 2006 model of that bike had a redesigned head, all done quietly. No press. No recall on earlier bikes. That pissed me off. This is my second and last Yamaha. My bike never developed the problem, and with the mileage it has, I'm told it would have surfaced long before now. From db

SUZUKI GSXR Brake System Recall: This is a huge recall on GSX-R models from 2004-2013. The problem is with the front brakes, leading to a spongy feeling, according to the company. Suzuki reports that moisture is being naturally absorbed by the brake fluid affecting the return spring inside the master cylinder. The issue affects numerous GSXR models including the GSX-R600, 750 and 1000. A list of models affected follows:

GSX-R600: K4, K5, K6,7,8,9, L0, L1, 2, and L3 models **GSX-R750-**K4,5,6,7,8,9, L0,1,2, 3 **GSX-R1000-**K5,6,7,8,9,L0,1,2,3

TEN THINGS TO THINK ABOUT IF YOU ARE ARRESTED

1. When am I arrested?

You are arrested, or considered under arrest, when Officers deprive you of your freedom of movement in order to have you answer questions for an alleged crime.

2. They want me to answer questions. What are my rights?

You have the right to remain silent. Anything you say can be used in court against you. You can stop answering questions at any time. You have the right to speak with your lawyer and have them there with you during questioning.

3 The cops won't let me go, but they haven't arrested me. Can they do that?

An Officer can detain you in order to obtain identification and an explanation of your presence at a particular time. You can be subjected to a limited pat-down search to ensure you have no weapons, if the Officer believes you are armed. You have the right to not answer any questions, but if you refuse to provide identification, the Officer may have grounds to arrest you. Once your temporary detention is over, the Officer must either arrest you or let you proceed on your way.

4. They want to arrest me but don't have a warrant.

Officers can make an arrest without a warrant if they see the offense being committed. They can also arrest if they have information that the suspect committed a felony and is about to escape.

5. The police hurt me.

The Officer is entitled to use reasonable force. So, the amount of force they can use depends on the situation.

6. They want to search my house. Do I have to let them in?

Officers may conduct a limited search without a warrant. If you are in your home, they may seize contraband, stolen property, or evidence of a crime in plain sight. They can check the residence for accomplices. If you are in your car, they may search for weapons that could be used against them. They may not conduct a broader search without a warrant unless they reasonably believe that the vehicle/motorcycle has evidence or contraband.

7. I've been arrested. Now what?

You are going to be taken to a detention facility where you will be able to speak to an attorney. They should also let you see the charge being alleged. You can be required to participate in a line-up, give a handwriting sample, give a blood or urine sample or perform other tasks.

8. I want out and they won't let me do what I want in jail.


Bail may or may not be set for your case depending on the seriousness of the charge. If the charge is relatively minor, you may be released on your own recognizance. You can also petition the court to reduce the amount of bail set.

9. Do I need a lawyer?

If you don't have a lawyer, you can call your state or county bar association for a referral to criminal lawyers. If you can't afford to hire an attorney, tell the judge, who will ask you questions to determine if you qualify for a public defender.

10. My kid just called from jail. What rights do they have?

Children have the same substantive rights as adults. In addition, they have the right to have a parent with them when being questioned. The procedures in juvenile court are generally closed to the public.

Jumpstart, a simulated riding experience, will conduct a 2014 tour down Route 66 and visit more than 30 Harley-Davidson dealerships through the end of the year. In 2015, Project LiveWire Experience will continue into more of the US, Canada, and Europe.



The ride blends styling heritage with the latest technology to deliver a new expression of the HD look, sound and feel. "Project LiveWire is more like the first electric guitar-not an electric car," said Mark-Hans Richer, Senior Vice-President and Chief Marketing Officer, HD Motor Co. "Its an expression of individuality and iconic style that just happens to be electric." The bike offers a visceral riding experience with tire-shredding acceleration and an unmistakable new sound. "The sound is a distinct part of the thrill," said Richer. "Think fighter jet on an aircraft carrier." 

Advocacy needed to reduce moose collisions with motorcycles.

It's bad enough watching out for distracted drivers, gravel and other anticipated hazards on Alaska's summer roads but please keep a sharp eye out for moose as well. Moose vs. vehicle collisions are on the rise and unfortunately motorcycle collisions have led recent wildlife caused fatalities. There have been five fatalities in 2012 & 2013 and they follow:

1. May 20th, 2012. 25 year old in Wasilla,
2. July 15th, 2012. 57 year old in Delta Junction,
3. August 8th, 2012. 29 year old in Wasilla,
4. June 19th, 2013. 29 year old at MP 92.5 Glenn Highway.
5. July 3rd, 2013. 44 year old at MP 147 Parks Highway.

We know that sometimes there is nothing you can do when wildlife darts out in front of you from out of nowhere. After all, they're moose and most of the time they're going to do what they want to. However, A.B.A.T.E. has been asked to help champion some easy, needed changes that deal with highways and moose.

The Alaska Moose Federation (AMF), ABATE and many others have been working with Department of Transportation (DOT), since 2007, to help create the Strategic Highway Safety Plan (SHSP). This lists safety initiatives for Alaska's next 30 years. Some of the strategies, such as right-of-way clearing, lighting the Glenn Highway, and recently the fencing of the Minnesota Extension are clear examples that progress is being made. However, AMF asked for ABATE's help to make sure two remaining problems are dealt with.

Problem #1: All planting along roads and in roundabouts MUST be non-attractive to moose. All highway planners, regardless of what agency they are involved with, need a strong directive that willow, mountain ash, and other tasty trees and shrubs can no longer be planted in areas that will lead to moose on roads. Past plantings should be removed for safety. Period!

Problem #2: When cow moose are killed on roads, their orphaned calves tend to stay near-by. Fundamentally, the presence of moose in a highway right-of-way needs to be a DOT safety issue. Currently, this is overseen by Alaska Fish & Game (ADF&G). ADF&G is not nor will ever be a safety agency. DOT now needs to assume the decision of what is to be done with lingering moose on our highways.

The state and local governments need to do a better job with these two items. Motorcycles are replicating current car trends. Fifty-four and a half gallons by 2025 are the new fuel standards which are going to bring more 'SMART' cars to Alaska. The vehicles are getting smaller but the moose are not. If agencies continue to plant 'moose food' and disregard wildlife on roads, they need to tell ABATE and other stake holders. Thank you.




